## ACCOUNTS ASSIGNMENT

#### **TOPIC : INTRODUCTION TO ACCOUNTING**

#### Introduction :

A businessman wants to know how much profit/loss he has made during the year. For this purpose accounts are prepared, so that at the end of accounting period, a businessman can understand that what are the assets and liabilities of the business.

#### Steps involved in accounting:

- 1) Indentifying business transaction is the first step of accounting.
- 2) These transactions are recorded in the subsidiary books and journal proper.
- 3) With the help of these books we prepare ledger accounts.
- 4) The balances shown by ledger accounts are used for preparing trial balance.
- 5) Trial balance serves as the basis for the preparation of financial statements.
- 6) Financial statements are classified as income statements and position statement.

7) Income statement consists of making trading account which shows gross profit/loss and profit and loss account showing net profit/loss of the business.

8) Finally, position statement (balance sheet) is prepared which reflects the true position of assets and Liabilities.

In this way prime object of the business accounting is to measure and report the profitability and financial status of the business.

Meaning of Accounting:

Accounting is the process of identifying, measuring, recording and communicating the

required information relating to the economic events of an organisation to the interested users of such information.

Accounting plays important role in providing quantitative information, primarily financial in nature, about economic entities, that is intended to be useful in making economic decisions.

So in short, Accounting is the art of recording, classifying, summarizing and interpreting the result thereof is called Accounting.

#### 1. Recording

All transaction should be recorded in the book of original entry.

#### 2. Classifying

All entries in the general should be posted to the appropriate ledger accounts.

3. Summarizing

The last stage is to prepare the trial balance and final accounts to show what profit earned or loss suffered by the company.
